Applicant and the applicant's Employer or Sponsor Company hereby represent to METL-SPAN that: (1) the applicant is an experienced installer of metal roof and wall products and has been actively involved in the installation of metal roof and wall products for the three (3) years immediately preceding this application; (2) applicant and/or Employer or Sponsor Company shall provide to METL-SPAN with this application, proof of General Liability Insurance or approved equivalent and a certificate showing that there is, in force, worker's compensation insurance for applicant and/or Employer or Sponsor Company; (3) Neither applicant or Employer/Sponsor have filed a petition seeking relief under the Bankruptcy Code; (4) Insurance Certificate copy available or on file of applicant's company including Workers' Compensation Waiver of Subrogation in favor of METL-SPAN.

Applicant shall provide to METL-SPAN a list of five (5) metal roof and wall projects that he/she has recently completed including the name of a person to contact at the project, phone number, and project address. The applicant hereby grants to METL-SPAN the right to contact the designated individual for the purpose of inspecting the work and/or assuring owner satisfaction with the work. If applicant is accepted by METL-SPAN for training in its Installer Certification Program, applicant agrees to attend the complete program at the METL-SPAN facility designated per the Installer Certification Program schedule or another location acceptable to METL-SPAN. METL-SPAN's Installer Certification Program ONLY assures that: (1) METL-SPAN has provided training to the applicant; (2) the applicant has completed an instructional course in the proper installation of the products eligible for certification. METL-SPAN shall not undertake the responsibility nor obligation to: (1) determine if the certified applicant is utilizing the methods and procedures taught in the program; (2) re-certify or inspect a certified applicant's work in order to determine whether proper methods and procedures taught in the program were followed.

The training program for which the applicant submits this application shall take place at a time and place to be designated by METL-SPAN in writing to the applicant and the applicant's Employer or Sponsor Company.

Applicant is an "independent contractor" and this Application is NOT intended to create an agent or employer/employee relationship or partnership of any kind. NCI may revoke Applicant's Installer Certification designation at any time for any reason in its sole discretion. ADDITIONALLY, APPLICANT AGREES TO DEFEND, INDEMNIFY AND SAVE NCI HARMLESS FROM ANY LIABILITIES, CLAIMS, OR DEMANDS (INCLUDING THE COSTS, EXPENSES AND ATTORNEYS' AND EXPERTS' FEES ON ACCOUNT THEREOF) THAT MAY BE MADE BY ANYONE FOR INJURIES TO PERSONS OR DAMAGE TO PROPERTY

**Registration & Fees:**

Course fees are: (1) \$275 for the first applicant, \$225 for second applicant and \$150 for third applicant and all subsequent applicants per company or organization per session; (2) \$50 for individuals wishing to attend for audit purposes only and either not eligible for certification or not requiring certification. This fee can be applied toward full certification costs if at a later date the attendee chooses to become a certified installer provided the applicant meets all other certification criteria. Audit Only spaces are limited to a maximum of 10 per class. All checks should be made out to METL-SPAN.

Course fees pay strictly for the costs and expenses of the training program. Included in the fees are METL-SPAN provided lunches on the first and second days of class. All expenses for travel, transportation, lodging and meals shall be borne by the applicant or the applicant's Employer or Sponsor Company.

\* Cancellation notices received a minimum of two (2) business days prior to class start date are eligible for refund of application and class fees.
